Draft minutes of the meeting held on Monday 2 June 2008 at 7.30 p.m. in the Village Hall, Hardwicke

Seven parishioners, Mr D. L. Tomlins (GCC), and the Clerk. **Apologies** were received from Mrs Box, Mr Hunt, Mr Middle, Mrs Mumford, Mr Newell and Mr Littleton (SDC). There were no **Declarations of Interest.** The Minutes of the meeting of 6 May, having been circulated, were confirmed as a true record and signed by the Chairman.

61/08 PLAYING FIELD AGREEMENTS

Members considered the revised Agreements drawn up following the meeting with the Cricket, Football, Rangers and Sunday Football club representatives on 19 May. The Cricket Club had asked for compensation for the weekend of the Rangers tournament. This was not agreed, and the Club would be asked for the return of the council's donation towards development of the new facility in Pound Lane, still on hold. The Sunday Football Club had asked whether the maximum of ten games included Cup games (it did). All four Agreements were signed by the Chairman and would be forwarded to the Clubs for countersigning. It was agreed that pitch fees would have to be considerably increased when next reviewed in February. Mr Dawe would take over from Mr King as the contact for the grasscutting contractor and to have overall responsibility for deciding the suitability of the pitch(es) in adverse weather.

62/08 COUNTY COUNCILLORS' REPORT

Mr Tomlins reported on the meeting on 22 May to discuss the provision of a culvert in Church Lane, which had been given emergency rating and would be done as soon as possible. Representatives of County and District councils, Environment Agency, Hardwicke Court Estate, parish council and local residents had been present.

The Chairman adjourned the meeting for public participation. There was considerable discussion of overgrown roundabouts and verges (Mr Tomlins to report to Highways), rats at the Pond (Clerk would report again to SDC Environmental Health), disturbance from youths congregating at the Play Area, and the provision of CCTV there. The meeting was then reconvened.

63/08 MATTERS ARISING FROM THE MINUTES

59/08 Data Protection: As a result of the council's decision at the last meeting, the contact addresses for councillors had been removed from the notice boards. The Clerk felt that this was wrong, in the interests of democracy, and had asked the council to reconsider, in the light of advice from GAPTC. However, members felt that this was a decision to be voted upon by more members than the five present (Mrs Smith had had to leave early) and would be put on the agenda for July.

Elmgrove Estate Play Area

Youths congregating at the Play Area had been troublesome recently, using the football shelters (the Club would be asked to deal with the graffiti). Police and Wardens had been asked to attend more often.

The Pond

FWAG report awaited (Clerk to remind them). SDC Environmental Health had been warned that the "rats" at the Pond might be watervoles but local residents were sure they were rats so the Clerk would write again.

Bledisloe Cup

Posters had been displayed; first round judging would take place between 1 and 15 June.

Grass Cutting

There had been a request for extra works to the cricket outfield (estimate from Hawkins awaited). The cutting at the Church had been unsatisfactory so far (the Vicar had written and the Clerk would reply) but the contractor had been having problems and had promised to improve. The grassed area of the new cremation area would be seeded by another (Mr Middle to oversee the works) as soon as possible.

Litter Picking

Councillors agreed to renew Mrs Edwards' contract at the end of July, at a rate to be confirmed later.

This had been booked for 18-22 August. Insurance had been arranged.

69/08 **TRAFFIC**

Mr Butler had produced a written report which would circulate to all members and had been copied to Mr Roberts of Highways. He had assembled a large amount of data and hoped that the council would be able to formulate a scheme for presentation to Highways later. He was thanked for his work on this subject.
