30/18 County Councillor and District Councillor Reports

County Cllr Stephen Davies reported on the County Council's budget for 2018/19. The Council had approved an increase in expenditure on adult care and children's services. Overall there would be a 4.5% increase in Council Tax.

County Cllrs had been allocated a budget of £30,000 for highways works in their division and the Parish Council was invited to identify particular projects.

District Councillor Gill Oxley gave an update of the planning application for Bellway Homes at Hunts Grove. Stroud District Council had approved a £2m loan for the redevelopment of Merrywalks Centre Stroud.

Resolved to support the application with a request that the Planning Authority requires the identified discrepancy be corrected

33/18 Section 106 Projects

The Council discussed the presentation from Hardwicke Rangers Football Club and the clubs proposals for improved facilities and community work. Members considered what level of support could be provided through S 106 funding. The Clerk advised that the total sum available from S106, which was held by Stroud District Council was around £75,000. Any proposed projects would require the support of the district council and would need to meet the criteria set out within the S 106 agreement of providing youth and adult recreation. Members noted the requirement to support the age groups identified and felt that projects should be equally supported and agreed to a sum of £35,000 being set aside to support the football club, the remainder to be used for adult recreation projects. It was also agreed that the club be urged to use sports facilities based within Hardwicke.

Resolved; Subject to approval by Stroud District Council, to support the football club building project with a sum of £35,000 from Section 106 funding and to urge the club to utilise sports facilities within the Hardwicke Parish

34/18 Parish Councillor and Lead Member Reports

Cllr Darren Morris reported that contractors were now following the allowed site working times and the situation would be monitored.

Cllr Kevin Marsden asked for a progress report on using social media to broaden the communication with residents. He noted that work was still to be completed on reports for the open spaces and requirements log. The previous motion on working policies could be withdrawn as this was being pursued under the Local Council Award Scheme. Cllr Marsden noted that work need to be undertaken on the Council's Emergency Planning and identifying vulnerable groups.

Cllr Demelza Turner-Wilkes reported that there had been issues of dog fouling in a number of areas in Hunts Grove. The Clerk agreed to speak to the dog warden to ask for assistance.

The Chair, Cllr John Perkin noted that the footpath from Green lane across the first field was badly overgrown and needed to be cut back.
