

GLOUCESTERSHIRE COUNTY COUNCIL
TEMPORARY CLOSURE VARIOUS ROADS
(HARESFIELD AND HARDWICKE PARISHES)
STROUD DISTRICT SPECIAL EVENT ORDER 2019

WHEREAS the Gloucestershire County Council (“the Council”) being the Traffic Authority for Various Roads within Stroud District as defined in the schedule below (“the Roads”) is satisfied that traffic along the Roads should be prohibited and restricted for the purpose of facilitating the holding of a relevant event namely the Gloucester 20 Road Race 2019.

NOW THEREFORE the Council in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic Regulation (Special Events) Act 1994), hereby makes the following Order:-

1. Except for pedestrian access to properties, no person shall proceed nor cause or permit any Vehicle to proceed along the Roads
2. In this Order –

“Motor Vehicle” means a mechanically propelled vehicle intended or adapted for use on the Roads as defined in Section 185 of the Road Traffic Act 1988

“Vehicle” means a Motor Vehicle or any other vehicle unless specifically exempted by the provisions of this Order
3. Nothing in Article 1 shall render it unlawful for a Vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Roads
4. Nothing in Article 1 shall render it unlawful for a Vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Roads
5. The Roads fall in the Haresfield and Hardwicke Parishes in the Stroud District within the County of Gloucestershire
6. This Order shall come into operation on the 17th March 2019 and shall continue in force for a period not exceeding three days
7. This Order may be cited as “Gloucestershire County Council Temporary Closure Various Roads (Haresfield and Hardwicke Parishes) Stroud District Special Event Order 2019”.

Gloucestershire County Council has made an Order to close and restrict temporarily under Section 16A of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic Regulation (Special Events) Act 1994) parts of the roads as detailed in the schedule below:-

The Council is satisfied that the use of the roads should be prohibited and restricted for the purpose of facilitating the holding of a relevant event namely the Gloucester 20 Road Race 2019.

The roads fall within the Haresfield and Hardwicke Parishes in the Stroud District within the County of Gloucestershire.

The Order comes into force between the hours of 09:00 and 14:00 on the 17th March 2019.
