The Elmore Road East planning application has raised public concern. It was agreed to request a site visit, and that Cllr Littleton be requested to take this to Committee.

Anti-social driving was discussed. Additional speed limit signs, a 'School' sign, and speed checks were suggested. The Roads and Traffic Safety Committee will work on this.

65/11 POLICE REPORT

The walk around the Overbrook Road area had taken place. It was agreed the area needs improvement, including repairs to the planters some of which have been damaged by plant growth. Cllr Kingsnorth will work with PC Mackie, the Neighbourhood Warden and GCC and report back to the next HPC meeting.

An update is awaited from the Charities Commission on the future of the Youth Club; it is due to shut on 16th July. There was full parish council support of the suggestion of funding the youth club jointly with Quedgeley. PC Mackie will assist with questions regarding CRB checks.

Speed checks have been taken in the area. All motorists exceeding 40mph on Bristol Road were issued a speeding ticket. Those travelling between 33 and 40mph were given words of advice.
