TEMPORARY CLOSURE OF 41209 NAAS LANE AND 41202 POOL FARM
ROAD (HARDWICKE, HARESFIELD, BROOKTHORPE WITH WHADDON
PARISHES AND QUEDGELEY TOWN) (STROUD DISTRICT AND
GLOUCESTER CITY) SPECIAL EVENT ORDER 2020

WHEREAS the Gloucestershire County Council ("the Council") being the Traffic Authority for 41209 Naas Lane and 41202 Pool Farm within Stroud District and Gloucester City as defined in Schedule 1 and 2 below ("the Roads") and having obtained the necessary consent from the Secretary of State for Transport for the Order to permit the closure of the roads more than once in a calendar year ("the Consent") is satisfied that traffic along the Roads should be prohibited for the purpose of facilitating the holding of a relevant event namely the Gloucester 20 Road Race.

NOW THEREFORE the Council in exercise of its powers under Section 16A of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic Regulation (Special Events) Act 1994), hereby makes the following Order:-

1. No person shall proceed nor cause or permit any Vehicle to proceed along the Road in an easterly direction as described in Schedule 1 below.

2. Except for pedestrian access to properties, no person shall proceed nor cause or permit any Vehicle to proceed along the Road as described in Schedule 2 below.

3. In this Order –

“Motor Vehicle” means a mechanically propelled vehicle intended or adapted for use on the Roads as defined in Section 185 of the Road Traffic Act 1988

“Vehicle” means a Motor Vehicle or any other vehicle unless specifically exempted by the provisions of this Order

4. Nothing in Articles 1 and 2 shall render it unlawful for a Vehicle being used for Police, Fire Brigade or Ambulance purposes to proceed along the Roads as defined in Schedules 1 and 2

5. Nothing in Articles 1 and 2 shall render it unlawful for a Vehicle being used by a statutory undertaker responding to an emergency situation to proceed along the Roads as defined in Schedules 1 and 2

6. The Roads fall in the Hardwicke, Haresfield, Brookthorpe with Whaddon Parishes and Quedgeley Town in the Stroud District and Gloucester City within the County of Gloucestershire.

7. This Order shall come into operation on the 15th March 2020 and shall continue in force for a period not exceeding three days
8. This Order may be cited as "Gloucestershire County Council Temporary Closure of 41209 Naas Lane and 41202 Pool Farm Road (Hardwicke, Haresfield, Brookthorpe with Whaddon Parishes and Quedgeley Town) (Stroud District and Gloucester City) Special Event Order 2020 "
9. In the event of any inconsistency or ambiguity between the content of this Temporary Order and any existing permanent/experimental Order(s) imposing restriction(s) on the Roads or diversion routes the latter will be suspended for the duration of the event and the provisions of this Temporary Order shall prevail during that period.

SCHEDULE 1 ONE WAY CLOSURE IN EASTERLY DIRECTION ONLY

41209 Naas Lane from outside SMH Fleet Solutions to its junction with Haresfield/Brookthorpe Road for a distance of approximately 2.5 kilometres.

SCHEDULE 2 ROAD CLOSURE

41202 Pool Farm Road from its junction with Haresfield Lane to the Railway Bridge for a distance of approximately 900 Metres.

Gloucestershire County Council has with the consent of the Secretary of State for Transport made an Order to close temporarily under Section 16A of the Road Traffic Regulation Act 1984 (as amended by the Road Traffic Regulation (Special Events) Act 1994) part of the roads as defined in Schedule 1 and 2 below.

SCHEDULE 1 ONE WAY CLOSURE IN EASTERLY DIRECTION ONLY

41209 Naas Lane from outside SMH Fleet Solutions to its junction with Haresfield/Brookthorpe Road for a distance of approximately 2.5 kilometres.

SCHEDULE 2 ROAD CLOSURE

41202 Pool Farm Road from its junction with Haresfield Lane to the Railway Bridge for a distance of approximately 900 Metres.

The Council is satisfied that the use of the roads should be prohibited for the purpose of facilitating the holding of a relevant event namely the Gloucester 20 Road Race.

The roads fall within Hardwicke, Haresfield and Brookthorpe with Whaddon Parishes and Quedgeley Town in the Stroud District and Gloucester City within the County of Gloucestershire.

The Order comes into force on 15th March 2020 between the hours of 09:00 and 14:00.

Alternative Route – As signed on site.

Pedestrian access to premises on or next to the road and emergency access will be maintained.
