44/21 Parish Councillor Reports

Clir Ian Butler reported that the footpath from Green Lane through to the church had been ploughed over and the area had been ploughed up to the edge of the field.

Cllr Graham Brearley noted the continuing issue of speeding vehicles along the lanes. He asked if a request could be made to the area highways manager, as to whether there had been in any changes in the criteria for a 20 mph speed limit.

Cllr Jill Brearley reported that the wooden bridge across the brook near to Puddleducks was in need of repair.

Cllr Denise Powell asked if the car park at the village hall could be cleared and for the accessible parking spaces to be repainted and for the number of spaces to be increased to three.

The Chair, Cllr John Perkin noted that there was increased litter around the youth shelter and proposed that a new litter bin be purchased and located near to the shelter.
