The Electoral Commission

The UK Government has introduced a requirement for voters to show photo ID when voting at a polling station at some elections. This new requirement will apply for the first time in England at the local elections on Thursday 4 May 2023.

Anyone who does not have an accepted form of photo ID will be able to apply for a free voter ID document, known as a Voter Authority Certificate.

We know that some groups are more likely to experience barriers in preparing for this change and may need support to access photo ID.

We've created this pack for organisations in England. It's designed to help you raise awareness, and support people you work with to apply for a Voter Authority Certificate, if needed. This pack also includes information on voter registration.

What you'll find in this pack:

- **A guide for your staff and volunteers**
- **A booklet and A5 summary 'insert' for voters**
- **Posters**
- **Digital resources**, including social media graphics, template social copy and web and newsletter content
- **Other resources**, including template press releases and resources for people working with specific groups

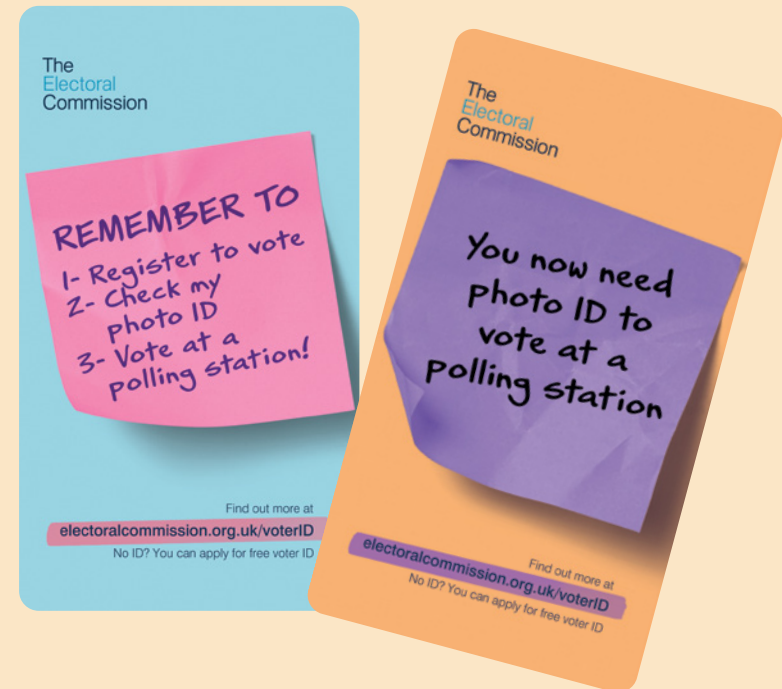
Social media graphics
