

**GLOUCESTERSHIRE COUNTY COUNCIL
 (50 MPH SPEED LIMIT) (BATH ROAD A430/A38/B4008)
 (PARISHES OF HARDWICKE, HUNTS GROVE, HARESFIELD AND STANDISH)
 (STROUD DISTRICT) ORDER 2023**

The Gloucestershire County Council (“the Council”) in exercise of its powers under Section 84 of the Road Traffic Regulation Act 1984 (“the Act”) and Part IV of Schedule 9 of the Act and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of that Schedule hereby make the following Order:-

1. (i) This Order shall come into operation on the 31st July 2023 and may be cited as the “GLOUCESTERSHIRE COUNTY COUNCIL (50 MPH SPEED LIMIT) (BATH ROAD A430/A38/B4008) (PARISHES OF HARDWICKE, HUNTS GROVE, HARESFIELD AND STANDISH) (STROUD DISTRICT) ORDER 2023”.
- (ii) This Order affects roads within the Parishes of Hardwicke, Hunts Grove, Haresfield and Standish within the Stroud District in the County of Gloucestershire.
2. In this Order –

 “Motor Vehicle” means a mechanically propelled vehicle intended or adapted for use on the roads as defined in Section 185 of the Road Traffic Act 1988.
3. No person shall cause or permit any Motor Vehicle to proceed along those lengths of roads described in the Schedule to this Order at a speed exceeding 50 MPH.
4. No speed limit imposed by this Order applies to vehicles falling within Regulation 3(4) of the Road Traffic Exemption (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with Regulation 3(5) of those regulations.
5. In accordance with Part IV of Schedule 9 of the 1984 Act, the following part of the GLOUCESTERSHIRE COUNTY COUNCIL (60MPH SPEED LIMITS) (A38 SOUTHERN CONNECTOR, GLOUCESTER) ORDER 2018 is hereby revoked as specified in the sub-Article below:

60 MPH SPEED LIMITS

Name: Bath Road, Hardwicke Number: B4008	<i>In a southerly direction.</i> From its junction with the Cross Keys roundabout for approximately 50 metres in a south easterly direction. <i>In a northerly direction.</i> From a point approximately 50 metres from its junction with the Cross Keys roundabout in a north westerly direction.

THE SCHEDULE
50MPH SPEED LIMIT TO BE INTRODUCED

Road Name & Number	Extent
Bath Road (A430)	From its junction with the Cross Keys roundabout for approximately 500 metres in a south easterly direction.
Bath Road (A38)	From a point approximately 500 metres south-east of its junction with the Cross Keys roundabout in a north-westerly direction to the Cross Keys roundabout.
Bath Road (B4008)	From its junction with Mount Farm Lane (401322) in a south-easterly direction to a point approximately 310 metres north of its junction with The Lane to Warren Farm (501136) to join up with the existing 50mph speed limit.
